



TERMS AND CONDITIONS

Free Screening Questionnaire on Children's Communication Development

§1. GENERAL PROVISIONS

1. The organiser of the initiative is Pineapple Therapy Julia Bieniasz-Brągiel and Krystian Brągiel civil partnership, with its registered office at Herbu Janina 11b/23, 02-972 Warsaw, Poland.
2. The initiative has an informational and preventive character and is addressed to parents or legal guardians of children.

§2. PURPOSE OF THE INITIATIVE

1. The purpose of the initiative is to conduct a screening, orientation-level assessment of selected aspects of a child's communication and speech development, based on information provided by the parent or legal guardian.
2. The initiative also has an informational and educational purpose, particularly in relation to early communication and articulation development.
3. The screening does not constitute a clinical diagnosis nor a psychological or educational opinion.

§3. AGE RANGE AND LANGUAGE VERSIONS

1. The screening tools are intended for children aged 18–47 months (up to the day preceding the child's 4th birthday).
2. The screening is conducted using separate language versions of the tools, which constitute independent adaptations.
3. The English-language version of the communication development tool (LUI – Pragmatic Language Development) includes reference points covering the full age range indicated above.
4. The Polish-language version of the communication development tool has been standardised only for selected age points: 20, 30, and 44 months.
5. For children outside the age points listed above, the use of the Polish-language version has an orientation-level character.

§4. SCREENING TOOLS USED WITHIN THE INITIATIVE

1. The screening consists of two screening tools completed electronically by the parent or legal guardian.
2. The first tool is a questionnaire used to assess pragmatic communication development (LUI – Pragmatic Language Development).
3. The second tool is a questionnaire used for an orientation-level assessment of articulation development, developed by the organiser's speech-language therapists and based on current professional knowledge regarding typical stages of speech sound development.



- Both tools have a screening character and are intended for an initial, orientation-level assessment of selected aspects of speech and communication development.

§5. FEEDBACK

- Following analysis of the completed tools, the organiser prepares written feedback.
- Feedback is provided within 14 days from completion of the questionnaires.
- The written feedback is delivered to the address indicated by the parent or legal guardian (home address or childcare institution) and includes the stamp and signature of the specialist responsible for the analysis.
- The feedback has an orientation-level character and does not constitute a clinical diagnosis or a psychological or educational opinion.
- Feedback may be shared with the child's childcare institution only with the explicit consent of the parent or legal guardian.

§6. INTERPRETATION OF RESULTS AND LIMITATIONS

- Interpretation of results from both tools is screening-based and orientation-level.
- Conclusions are formulated taking into account the child's age, the language version of the tools used, and the limitations resulting from the scope of standardisation or lack thereof.
- Articulation development is interpreted based on widely accepted professional knowledge regarding developmental stages of speech sound acquisition.
- These stages may include speech sounds that typically emerge after the age of four; lack of such sounds within the age range covered by the initiative may be developmentally typical.
- Articulation-related results do not constitute an independent basis for therapeutic decision-making.

§7. VOLUNTARY PARTICIPATION

- Participation in the initiative is entirely voluntary and free of charge.
- The parent or legal guardian may withdraw consent to participate at any time without providing a reason.

§8. FINAL PROVISIONS

- The organiser reserves the right to terminate the initiative at any time.
- Matters not regulated herein are governed by applicable provisions of Polish law.
